- 1. Minutes. Approved.
- 2. Treasurer's Report: Note revised GMB numbers in Barry's report. Did not actually lose money.
- 3. Spirit & Place 2012. Need to brainstorm possible collaborators that would work for the theme "play."
 - a. Congregation Beth-El Zedeck? They have a portable dance floor.
 - b. Jewish Community Center has multiple dance / exercise activities.

4. Location:

- a. Earth House:
 - i. We haven't had a contract with them for 2 years.
 - ii. Concerned about liability issues, particularly safety things we have reported but that they haven't fixed; primarily poor lighting and holes in the floor.
 - iii. Bad lighting outside, near ladies room, etc. Lights regularly don't work and are not bright when they do.
 - iv. Slow and poor response to our complaints.
 - v. Plumbing not modern. Ladies toilet routinely has to be specially flushed, sink water always cold
 - vi. Slow response on repairs. Fixing holes in the floor took months, during which we had to block off those places ourselves.
 - vii. Weekend events extremely expensive. More than whole weekend cost for GMB?

b. Zion

- i. May be much more affordable for weekend events.
- ii. Plusses: convenient and safe feeling parking, good lighting, nice, modern restrooms, handicap accessible, attractive.
- iii. Juliet will arrange a meeting with Zion building use committee.
- iv. Will any dancers be uncomfortable in a church, or church uncomfortable with any dancers?
- c. Joy to All Who Sorrow Church where folk dancing happens on Fridays. It's smaller, no stage, probably much cheaper, worth looking into if need be.

- d. Athenaeum started at \$50/week, then \$75, then \$100. Mediocre lighting, no stage, occasional parking issues.
- 5. Great Bear Trio We had thought they might be available after Pigtown Fling, but probably not.

6. GMB 2012
